

Allied Air Manufacturer Certification Statement Under The Nonbusiness Energy Property Tax Credits

FEDERAL TAX CREDITS FOR QUALIFIED ENERGY-EFFICIENT HVAC IMPROVEMENTS— RESIDENTIAL AIR CONDITIONING PRODUCT CATEGORY

Taxpayers claiming a credit for Qualified Energy Property should retain this Certification Statement for taxpayer records.

The Further Consolidated Appropriations Act, 2020, the U.S. Internal Revenue Service (IRS) extended the Nonbusiness Energy Property Credit, Internal Revenue Code Section 25C for homeowners who make qualified improvements of higher-efficiency HVAC equipment to their primary residences. Tax credits are effective for all qualified energy property systems installed from January 1, 2017 through December 31, 2021.
